The City of La Center proposes to update its municipal code, LCMC 18.155 (Downtown Overlay District), to clarify what types of projects the overlay standards apply to and projects that would be exempt from the standards. The applicability statement in LCMC 18.155.020 of the existing code applies the Downtown Overlay standards to all development with the district and does not distinguish between different land uses or new development versus updates or remodels to existing development. Furthermore, the code requires compliance with the overlay standards for internal remodels that exceed 50 percent of the building assessed value – a strong disincentive for owners to make interior updates since they would be required to update the entirety of the exterior of their building and site even if proposed updates are limited to the interior of the building. The La Center Downtown Design Plan and Guidelines (2005) document that the overlay standards are based on was intended to apply to commercial uses only.

The proposed updates will limit the applicability of the downtown standards to: (1) all new commercial, mixed use, and multifamily uses and (2) major exterior redevelopment or rehabilitation of existing uses that requires a building permit. The draft code changes also specify that the Downtown Overlay code standards do not apply to: (1) New single-family construction or the exterior remodel of single-family residential uses (2) The interior remodel of buildings (3) Exterior building improvements that does not require a building permit and (4) Replacement of windows, awnings, roofing materials, or other exterior building elements for maintenance reasons only to match existing materials and design.

The update to the Downtown Overlay code applicability provisions will narrow the scope of the provisions to new commercial uses, mixed uses, and multifamily development and major exterior redevelopment or remodels. Most of the provisions in the code pertain to the exterior appearance of buildings, pedestrian connections, outdoor lighting, and parking. Narrowing the applicability is not likely to affect (either increase or decrease) discharges to water, emissions to air, production, storage or release of toxic or hazardous substances or production of noise.

Proposed measures to avoid or reduce such increases are:

2. How would the proposal be likely to affect plants, animals, fish, or marine life?

The update to the Downtown Overlay code applicability provisions will narrow the scope of the provisions to new commercial uses, mixed uses, and multifamily development and major exterior redevelopment or remodels. Most of the provisions in the code pertain to the exterior appearance of buildings, pedestrian connections, outdoor lighting, and parking. Narrowing the applicability is not likely to affect plants, animals, fish, or marine life.

Proposed measures to protect or conserve plants, animals, fish, or marine life are:

As is the case for all development, all projects that would affect fish and wildlife habitat conservation critical areas within the Downtown Overlay District would be required to comply with the City's critical areas ordinance.

3. How would the proposal be likely to deplete energy or natural resources?

The update to the Downtown Overlay District code applicability provisions will narrow the scope of the provisions to new commercial uses, mixed uses, and multifamily development and major exterior redevelopment or remodels. Most of the provisions in the code pertain to the exterior appearance of buildings, pedestrian connections, outdoor lighting, and parking. Narrowing the applicability will require less extensive changes to sites thereby encouraging building owners to make interior improvements and exterior improvements without requiring overly burdensome and expensive improvements. In theory, this will encourage more development and new construction in downtown that will, in turn, nominally increase energy use during construction and for operation of the new uses.

Proposed measures to protect or conserve energy and natural resources are:

Project-specific SEPA's will be necessary and may encourage energy reduction techniques such as using biofuels in construction vehicles or requiring energy-efficient lighting to be used in and outside of buildings. Future proposals will also be subject to the City's outdoor lighting code in LCMC 18.282 which requires more energy-efficient lighting.

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

The proposal would not affect environmentally sensitive areas, historic or cultural sites, wetlands, floodplains, or prime farmlands.

Proposed measures to protect such resources or to avoid or reduce impacts are:

All future site-specific proposals that affect environmentally sensitive areas, historic or cultural sites, wetlands, floodplains, or prime farmland within the Downtown Overlay zone would be required to comply with applicable City regulations including critical areas (LCMC 18.300), environmental protection (LCMC 18.310), and Archaeological Resource Protection (LCMC 18.360).

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

The updated code language for the applicability section of the Downtown Overlay District will narrow the scope of projects subject to the overlay standards and bring the code closer in line with the

intention of the La Center Downtown Design Plan and Guidelines (2005) that recommended applying the design guidelines only to new commercial uses. Therefore, the proposed code update would bring the code into better alignment with the City's land use plans.

The Downtown Overlay zone is located entirely outside of the City's regulated shoreline jurisdiction.

Proposed measures to avoid or reduce shoreline and land use impacts are:

None. The code update will better align the code with the City's existing plans, especially the La Center Downtown Design Plan and Guidelines (2005).
